As per our letter of October 19th, 2006 Cambridge Mutual Fire Insurance Company forwarded the claim you submitted of damage to your vessel for our office to investigate. To that end, I inspected the damage to your vessel at your residence on October 31st, 2006.

There is little doubt that your vessel sustained damage as the result of a lighting strike as stated in your claim.

As the loss occurred immediately prior to your departing on vacation, repairs were conducted in small bits. I have verified all repairs already performed, and evaluated all repairs yet to be performed and prepared an estimate of repair as follows.
